
Tripp census and assessment records in Ontario.

PROBLEM

The objective of this report is to identify TRIPP households in Haldimand Township, Newcastle District, Upper Canada from early census and assessment records.

BACKGROUND

Haldimand Township is one of nine townships located in Northumberland County, Ontario. Northumberland County is one of the original 19 counties from 1792 when the Province of Upper Canada was formed.

From 1802 to 1849, Northumberland County was part of the Newcastle District. Among their various duties, District officials were responsible property assessment, taxation, and census enumerations. Surviving records from this period are now at the Archives of Ontario (http://www.archives.gov.on.ca) in Toronto. The following records have been microfilmed and available through Interlibrary Loan:

Newcastle District Census and Assessment Rolls, 1803-1850, Haldimand Township (ref. code F 1800-20), Archives of Ontario microfilm MS 16, reels 4-5.

Census and Assessment: 1826-1838 Assessment: 1808-1825; 1839-1847

The purpose of the assessment rolls is to annually collect information about a resident's personal and real property in order to determine the amount of tax due. The information collected varied over time but included a description of real property, building type, acres under cultivation, number and type of livestock, and number and ages of people living on the property.

A few notes regarding the lists. Missing and unreadable pages are noted. The original books do not contain page numbers so a list number (no. 1 is first on the list) is used to identify where the individual is found on the list. The original order of visitation is unknown; several lists were alphabetized and noted in brackets []. The assessed tax appears in the originals but it was not transcribed.

Early house assessment was based on the type of construction – "round logs," or "squared logs" but by 1826 "framed, under 2 story" and "framed 2 story" were added. Only the exceptions to "round log" construction are noted in brackets [].

The census and assessments were taken separately except for 1826-1839 as noted above. The separate census and assessment lists overlap for several years.

RECOMMENDATIONS FOR CONTINUING RESEARCH

- 1. Plot TRIPP assessment data on a Haldimand Township map to show visually where they lived.
- 2. Correlate the census and assessment data with TRIPP grantor and grantee land transactions.
- 3. Identify an approximate lot and concession for TRIPP households only appearing in the census lists. Do this by re-creating the neighborhood though the census visitation order and correlating it to the comparable assessment list.
