

TRIPP ADDITIONS AND CORRECTIONS

4:69. #7 iv. 2. Mercy Davol. For 1765 read 1735.

4:70. #9. Benjamin Tripp, of Dartmouth by 1715, having bought land there between 1712 and 1718, as the following conveyances from Bristol Co. Deeds show. Jeremiah Devil of Dartmouth, yeoman, to Benjamin Tripp of Portsmouth, 2 March 1712/3, 1:382, rec. 8:346; same to same, weaver, 27 March 1713, 1:384, rec. 8:348; Nathaniel Soule of Dartmouth, yeoman, to Benjamin Tripp of Dartmouth, yeoman, 19 July 1715, 2:491, rec. 14:66; Thomas Cornell of Dartmouth, farmer, to Benjamin Tripp of Dartmouth, weaver, 13 May 1718, 2:489, rec. 14:65. His will (note 129) left his homestead farm to his sons Nathaniel (#33) and Stokes (#9. vii). After Nathaniel died the tract was divided between his daughters Ann(a) and Mary (Tripp) Gifford [see 4:85-86] and his brother Stokes. Bristol Co. Deeds 13:75, 25 April 1791, rec. 4 April 1793, 71:530. Then Stokes died unmarried and Ann(a) and Mary bought his part of the tract from the other heirs [his sister Elizabeth (Tripp) Gifford, the children of his sister Catherine (Tripp) Tripp, and the children of his brother Benjamin Tripp]. Bristol Co. Deeds 14:499, 24 April 1797, rec. 16 April 1798, 76:498. The family burying place was reserved for the use of the grantors. This conveyance requires several additions to the children assigned to Benjamin⁴ Tripp (No. 32) and some amendment of the account of the family of Ebenezer⁴ and Catherine (Tripp) Tripp (No. 46). The grantors were: Elizabeth Gifford (X), Ebenezer Tripp, Alice Tripp (X), Elizabeth Tripp, Anthony Tripp (X), Culbert Tripp (X), Susanna Gidley (X), Lydia Tripp (X), James Tripp, Meribah Tripp (X), Ephraim Tripp, Thomas Tripp (X), Lot Tripp, Peleg Tripp (X), George Potter, Rebecca Potter (X) [(X) indicates signing by mark]. 4:71. #9 iv, v. Lydia and Rebecca Tripp dead by 24 April 1797, as not mentioned in Bristol Co. Deeds 14:499.

4:71. #9 vi. Elizabeth (Tripp) Gifford, alive 24 April 1797 (*id.*).

4:81. #24 vii. Anne Tripp m. Reed Ferris c. 30 March 1750 or 1751, according to Barbara Barth of Great Barrington, Mass. (correspondence with author)

4:82. #25 vii. Jane (Jean) Tripp m. Culbert Tripp, son of Benjamin⁴ Tripp (#32), who is not identical with Cousen (Constant) Tripp (#59 i.).

4:85. #32. Bristol Co. Deeds 14:499 confirms the two children now assigned to Benjamin⁴ Tripp but also permits us to add several others.
iii. Culbert, m. 18 Sept. 1774 (Dartmouth VR) Jane (Jean) Tripp (#25 vii.)
iv. Lydia, unm. 24 April 1797, also mentioned in the will of her brother Anthony Tripp (note 320).

v. Ephraim, living 24 April 1797.

vi. Thomas, living 24 April 1797, may well be one of the Thomas Tripps otherwise unidentified and noted on p. 109, ¶12 (and notes 620 and 621).

4:87. #35 ii. Ann Tripp d. 19 8 mo. 1828, aged c.85 (Quaker Births and Deaths, Nine Partners, p. 62).

#35 viii. Tabitha d. 12 4 mo. 1809, aged 53 yrs. 8 mos. (Quaker Deaths, New York Monthly Meeting 1796-1851 and 1827-1860, p.

17), m. 20 6 mo. 1781 William Knowles of Oblong, 1st int. 18 4 mo. 1781, 2nd int. 16 5 mo. 1781 (Oblong Monthly Meeting, p. 29).

4:87. #36 The wife of Job⁴ Tripp was not Sarah White, but Sarah Weeden, b. Newport 20 May 1704 (Newport VR), dau. of Joseph and Hannah (Davol) Weeden, as is established by the will of Joseph Weeden, dated 17 March 1744/5, proved 3 Sept. 1745 (Newport Town Council Records 9:91) which mentions his daughter Sarah Tripp. (Courtesy of Jesse L. 4:88, #36 v. Sarah Tripp m. (Capt.) George Waite, b. North Kingstown 16 Oct. 1721, d. Swanton, Franklin Co., Vt. Aug. 1782, son of Joseph and Elizabeth (Sheffield) Waite. Issue. (Courtesy of Jesse L. Warner)

4:93. #44 i. Some printed sources say that Eseck, son of Jonathan and Anne (Carr) Wood, b. Little Compton 13 Nov. 1720, m. 1742 Sarah, dau. of Ichabod Tripp and lived at Dartmouth. Benjamin F. Wilbour, *Little Compton Families* (Little Compton, R.I., 1967), p. 781, quoted by Randall, *Joseph Tripp*, pp. 5, 10, 11. Records also show a marriage in 1743 as shown by Isaac, son of Isaac and Mary (Potter) Wood to Sarah, dau. of Othniel and Mary (Potter) Tripp. (Courtesy of David W. Dumas)

4:94. #46 Katherine (Tripp) Tripp was dead by 24 April 1797, when her children were heirs to her brother Stokes Tripp (see above).

4:94. #46 Seven of the eight children were alive 24 April 1797, when they signed the conveyance of the family property. Theodate (#46 iii.) is not mentioned, nor are any of the ten children assigned to her and Peleg Potter by Charles E. Potter in *Genealogies of the Potter Families...* (Boston, 1888), part 8, p. 18 (family 1044). There seems to be no record of any of these children at Dartmouth or Tiverton and it remains possible that they belong to another Peleg Potter or to a different wife. On 24 April 1797 George and Rebecca Potter lived in Saratoga Co., N.Y. where they acknowledged their execution of the deed. Elizabeth (#46 v.) if unmarried in 1797, as it appears, would then *not* be the Elizabeth Tripp who married Elisha Russell, and the other suggestion of Randall that the wife of Elisha Russell was Elizabeth, daughter of Joseph⁴ Tripp (#57 iii.) may have merit, as we have no evidence apart from Randall's own word that she d. unm. in 1771. Further research is needed.

4:96. #50 John⁴ Tripp b. 1724, not 1744.

4:100. #59 i. Cousen is called Constant but not Culbert and he did not marry Jane (Jean) Tripp. His wife remains unknown. Note 525 should also be corrected accordingly. Culbert⁵ Tripp is a son of Benjamin⁴ Tripp (#32) above.

4:101. #63 Thomas⁴ Tripp d. 1766, not 1776.

4:104. #67 viii or ix. One of the two unknown children is Gideon Tripp, b. 23 May 1772, m. 18 April 1792 Sarah Mead, b. 14 Sept. 1772. Issue. (Courtesy Dorothy Riedell, Janesville, Wisconsin, from her family records)

4:108, line 10. James Tripp d. 1762 and not 1761.
